## Project Description

From the EIB's website:

Le Projet comprend la construction, la reconstruction ou la rénovation des collèges sous la responsabilité du Département de la Haute-Savoie en France.

Le projet soutient le plan d'investissement pour l'éducation du département de la Haute-Savoie, appelé « Plan collège ». Le projet contribuera au « Plan collège » en participant au financement de la part des travaux pour la période 2023-2027. Il comprend la construction, la reconstruction, l'extension et la rénovation d'écoles secondaires du premier cycle (collèges) ainsi que de certains équipements culturels, sportifs et sociaux associés (salle de demi-pension, terrain de sport, logements à destination du personnel enseignant, etc.). Les principaux objectifs du projet sont d'offrir de meilleures conditions d'apprentissage aux étudiants et à la communauté éducative, en améliorant l'infrastructure de l'éducation publique, et d'adapter le réseau scolaire aux changements de la demande locale, dans un contexte de forte croissance démographique. La portée exacte du projet sera examinée lors de l'évaluation.

The Project includes the construction, reconstruction or renovation of colleges under the responsibility of the Department of Haute-Savoie in France.

The project supports the Haute-Savoie department's investment plan for education, known as the "Plan collège". The project will contribute to the "Plan collège" by participating in the financing of the work share for the period 2023-2027. It includes the construction, reconstruction, extension and renovation of lower secondary schools (collèges) as well as certain associated cultural, sports and social facilities (half-boarding room, sports field, housing for teaching staff, etc.). The main objectives of the project are to provide better learning conditions for students and the educational community, by improving the public education infrastructure, and to adapt the school network to changes in local demand, in a context of strong demographic growth. The exact scope of the project will be reviewed during the evaluation.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. A complaint can be lodged via a written communication addressed to the Secretary General of the EIB, via email to the dedicated email address: [complaints@eib.org](mailto:complaints@eib.org), by completing the online complaint form available at the following address: <http://www.eib.org/complaints/form> via fax or delivered directly to the EIB Complaints Mechanism Division, any EIB local representation office or any EIB staff. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
