### Project Description

According to the Bank's website, the project consists of the construction and operation in Hagen, Germany, of an innovative first-of-its-kind commercial demonstration plant for the manufacturing of precursor cathode active material (nickel, manganese and cobalt in a specific ratio), which is used in the production of advanced Lithium-ion cells.

The project will demonstrate commercial-scale operation of an innovative technology to produce precursor cathode active material ("pCAM"). The production process utilises two novel processing steps, which reduce the carbon footprint, improve safety and reduce cost of manufacturing pCAM.

### ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
