### **Project Description**

As stated by the EIB, the project consists of several capital investment components in the field of innovative engineered stone products and production processes, in particular: (i) deployment of technology for next generation circular agglomerated materials, (ii) investment in renewable energy generation capacity for self-consumption, (iii) investment in automation, robotisation and digitalisation, and (iv) expansion of production capacity that will make use of renewable fuels. The project covers the period 2022-2025 and will be carried out at the promoter's existing site in Cantoria (Andalusia, Spain).

The project aims at expanding the Promoter's installed capacity through the deployment of modern and efficient machinery and equipment that will use locally produced hydrogen as the main power source in combination with other renewable fuels. The project will also improve the Promoter's capacity to recycle production by-products.

### **ACCOUNTABILITY MECHANISM OF EIB**

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
