Project Description

According to the Bank's website, the project concerns the financing of investments relating to the reconstruction, expansion of capacity and improvement of the environmental performance of the HALIOTIS wastewater treatment plant. This station is operated by Eau d'Azur and treats the majority of wastewater from the Nice Côte d'Azur Metropolis.

The project aims to improve wastewater treatment for approximately 550,000 inhabitants of the Nice Côte d'Azur Metropolis, with a nominal capacity of the future installation of 680,000 Inhabitant Equivalents.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
