Project Description

According to the Bank's website, the project concerns the renovation of 6 lower-secondary schools and a library, as well as the construction of a new sports hall under the responsibility of the Department of Puy-de-Dôme in France.

The main objective is to modernise and improve colleges infrastructure by adapting supply to changes in local demand, while strengthening and improving the education offering for lower-secondary school students. Additionally, the project seeks to strengthen the infrastructure resilience to the risks of climate change and increase the energy efficiency of the school estate.

Early Warning System Project Analysis

The project does not address specific new technologies or methodologies. All components will meet the current thermal regulations (RT2012 and RE2020 standards, depending on the date of issue of building permits) which are the national transposition of EU Directives. For some specific operations, the desired performance may go beyond regulation. The Department will not seek specific environmental sustainability labels.

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
