## Project Description

According to the Bank's website, the project concerns the construction and equipment of the new 'Hospital Civil' in Malaga. The new hospital, which will have 800 beds will integrate in one site the medical services currently being provided in different locations. The main investments are planned for the period 2022 - 2027.

The project supports the construction of a third hospital building adjacent to the 'Hospital Civil' and the Mother & Child Hospital on the main campus of the Regional Hospital of Malaga. This has been recognised in August 2022 by the Council of the Government of Andalucía as a project of interest (PIA- Proyecto de Interés Autonómico) for the Autonomous Community of Andalucía.

The aim is to address the urgent problems related to the provision medical healthcare to the local population, especially in the Malaga province: deficit of hospital beds and operating rooms, absence of day-hospital facilities, accelerated population ageing, shortage of healthcare staff and other health sector resources, increasing burden of chronic disease and higher costs for the provision of healthcare services.

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
