### Project Description

According to the EIB, the framework loan will support the energy-efficient upgrade of the existing surface water collection network as well as of Terminals 1 and 2.

It will also finance the construction of a photovoltaic farm, vehicle charging infrastructure and zero-emission vehicles.

The aim is to allow the Promoter to operate sustainably meeting the goals of existing and future regulations on the electrification of airport operations, building efficiency and waste water quality.

The project will allow the airport to maintain the level of compliance with standards on aviation safety and air transport security, improve service standards to passengers and ultimately, the operational resilience resulting from the infrastructure upgrade.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
