## Project Description

As stated by the EIB, the project will finance a rainwater drainage infrastructure targeting several secondary cities in Benin, covering 3 cities in the North of the country, Natitingou, Djougou and Kandi.

The aim is to extend and rehabilitate the primary and secondary rainwater drainage systems, as well as related roads of the concerned cities.

The project will significantly decrease flooding, as well as stagnating water, with a positive impact on human and economic development. It will considerably contribute to improve the living conditions of the population and to climate change adaptation.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
