### Project Description

As stated by the EIB, the project concerns the design, implementation and operation of a 1000MW offshore wind farm, including offshore substation and export cable, in the North Sea West of Nissum Fjord, at about 20 km from Jutland shore.

The offshore wind farm will primarily reduce carbon and air pollution emissions, which are externalities the market fails to address. It will rely on revenues from the wholesale market, as the 20-year support from the contract for difference support scheme is on a near-zero subsidy basis. The project will therefore improve market efficiency and competition.

### ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
