### Project Description

As stated by the EIB, the project consists in an investment programme for electricity distribution in the period 2023 to 2024, including refurbishment, upgrading and expansion of existing electricity distribution infrastructure and the installation of smart meters in five provinces in the Netherlands.

The project supports the modernization, reinforcement and digitalisation of the electricity distribution network infrastructure in five provinces in the Netherlands, in Groningen, Drenthe, Overijssel, North-Brabant and Limburg. The project caters for demand growth, the connection of new network users and the integration of renewables, improving the quality of service and the efficiency of operations.

The project supports the Netherlands' long-term climate strategy set out in the National Energy and Climate Plan (NECP) and EU policies on energy and climate, by enhancing and extending critical infrastructure for decarbonisation.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
