Project Description

According to the Bank's website, the project will finance the construction of a new A2 Motorway section between Minsk Mazowiecki and Biala Podlaska.

The aim is to contribute to better accessibility in the region, by adapting of the road technical and operational parameters to the forecast traffic level, removing bottlenecks as well as completing missing elements of the Trans-European network (TEN-T) road infrastructure. This will improve transit and local traffic flow organisation and driving conditions on the transport corridor. It will also contribute to improve traffic safety and living conditions for inhabitants alongside the existing National Road DK2.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
