## Project Description

As stated by the EIB, the project concerns the construction and operation of a processing plant for the production of edible oil from oilseeds, as well as the acquisition of railcars for the transportation of edible oil.

The aim is to support the development of sustainable primary production systems, supply healthy food and fibres and biomass for bio-based products and materials, as well as promote sustainability and resilience in rural and coastal areas through the improvement of existing or construction of new, rural and coastal infrastructure and facilities.

The project will generate climate benefits, by producing renewable energy based on discarded sunflower seed hulls. It will also reduce greenhouse gas emissions through the modal shift from railcars instead of trucks to transport edible oil and agricultural products to the port of Varna.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
