## Project Description

As stated by the EIB, Horizon Capital Growth Fund IV is a generalist fund supporting the growth of small and medium-sized enterprises active in Ukraine and Moldova.

Horizon Capital Growth Fund IV - USD 300m fund, providing growth and expansion capital in the form of equity and quasi-equity instruments in established, export-oriented companies and late-stage technology leaders with global and regional revenues benefitting from the significant pool of technical talent in Ukraine and Moldova. The project will have a significant impact on: (i) supporting job creation in Ukraine and Moldova, particularly among the youth; (ii) expanding the digitalisation of the countries; (iii) promoting and maintaining gender balance and gender smart practices within the fund and portfolio companies; (iv) increasing access to finance for MSMEs at a time where growth finance is and cost-prohibitive, further exacerbated by the current geopolitical turbulence; (v) raising ESG and corporate governance in portfolio companies.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
