According to the Bank's website, the project will finance the extension and renovation of the promoter's electricity distribution networks. A2A serves mainly the cities of Milan, Brescia, Cremona and their outskirts during the period 2023-2027.

The investment is expected to allow the promoter to connect new users, to improve the quality of the electricity supply, and cater for demand growth.

Sustainability is the focus of A2A's strategy: to support sustainable growth in Italy and make a real contribution to the energy transition and the circular economy, the group's business plan includes investment of €16 billion by 2030 in projects aligned with the SDGs of the UN 2030 Agenda.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
