

#### **Project Description**

As stated by the EIB, the project consists in the design, construction and operation of an integrated facility consisting of a 50 MW biomass cogeneration plant, carbon capture, green hydrogen production and green e-methanol plant (100kt production) in La Robla, Castilla y Leon.

The industrial cluster specifically aims to replace fossil fuels to decarbonise the energy and maritime transport sector. The plant also contributes to the REPowerEU objectives by enhancing the EU capacity of producing clean energy, such as emethanol. This will lead to reduce the dependency on fuel imports and thereby supports energy security.

#### **ACCOUNTABILITY MECHANISM OF EIB**

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
