## Project Description

As stated by the EIB, the Framework Loan will support investments under the City of Warsaw's Multiannual Financial Framework 2023-2029, including the Urban Development Strategy #Warsaw2030 and Climate Strategies.

All the schemes will be implemented within the City of Warsaw, located in the Mazowieckie Voivodship province.

The project covers, among others, urban development, regeneration, renewal with the new construction, refurbishment and upgrade of urban infrastructure, comprising public buildings (schools, health centres, nursing homes, sport, recreation and cultural facilities, etc.), open spaces and green areas.

It also covers, among other sectors, flood protection, Renewable Energy (RE) and Energy Efficiency (EE) investments, sustainable mobility, and modernisation of urban roads to include road safety and climate mitigation and adaptation measures.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
