## Project Description

According to the Bank's website, the project will co-finance small projects under Malta's Operational Programmes for the period 2021-2027 under the Cohesion Fund, the European Regional Development Fund (ERDF), the European Social Fund (ESF), the European Maritime, Fisheries and Aquaculture Fund (EMFAF) and Just Transition Fund (JTF).

This operation will support Malta's smart and sustainable growth by contributing to achieve the objectives of the Maltese Partnership Agreement on EU funds 2021-2027.

The related sub-projects, to be limited to an investment cost of EUR 50m each, will address multiple sectors, particularly energy, education, health, water as well as research, development and innovation.

The project will contribute to territorial cohesion and social inclusion (focus on specific groups and gender equality, for example). This will be further assessed during the appraisal and monitored throughout the implementation period.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
