### Project Description

As stated by the EIB, the project aims to support leasing and financing of zero-emission trucks and busses in several EU Member States such as Germany (for the main part), Belgium, France, the Netherlands and Spain.

The aim is to finance zero-emission battery-electric trucks and busses to support the transformation to sustainable mobility. The market for battery-electric trucks is at an early stage of development with high upfront costs.

By financing leasing companies, the EIB plays a significant role in support of EV deployment on the EU market, hence also supports scale up of the production of electric trucks while reducing the costs.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
