According to the Bank's website, the project consists of investments in the recovery and rehabilitation of existing 451 schools across Portugal.

The project's main objectives are to provide better learning conditions for primary and secondary students, by upgrading the public education infrastructure and equipment, and to adapt the school network to changes in the local demand.

#### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
