Project Description

According to the Bank's website, the project will finance wastewater treatment schemes under NILSA's 2023-2030 investment plan.

The aim is to comply with the requirements of Navarra's Water Master Plan and to meet a full circular economy and zero carbon footprint target.

The related investments will focus on three lines of action:


- i) centralized sludge treatment in Tudela and Arazuri wastewater treatment plants
- ii) upgrade and rehabilitation of existing wastewater treatment plants
- iii) wastewater treatment facilities in small agglomerations.



Early Warning System Project Analysis

This investment is expected to preserve the quality of water resources and to promote a clean and circular economy through the reutilisation of wastewater sludge in agriculture. It will, therefore, increase the quality of life in the project area. Social negative impacts are only temporary (e.g. safety hazards during construction, traffic, noise) and will be addressed as part of the planning for the implementation of each scheme. The promoter has demonstrated sound practices with respect to environmental, health and safety management and will be required to ensure compliance with the applicable legislation regarding social matters.

The project is expected to contribute to climate action and environmental sustainability (CA&ES) objectives, in particular to climate mitigation, pollution prevention and control, sustainable use and protection of water and marine resources.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union. 
