#### **Project Description**

According to the Company's website, this is an allocation under the EIB's signed project "Railway Development Framework Loan Croatia (2022-0660).

The present operation will finance investments into new passenger rolling stock to be used under a public service contract. In detail, it supports the purchase of:

- (i) six bi-mode (diesel-electric) multiple units to operate regional and intercity services on the route from Zagreb to Split
- (ii) four battery only powered multiple units to operate in the Split and Istrian region
- (iii) four battery-electrically powered multiple units on the routes Zagreb-Krapina and Zagreb-Bjelovar.

The aim of the new rolling stock is to replace the current outdated and technologically obsolete units.

The Project is located in two transition regions (Jadranska Hrvatska and Kontinentalna Hrvatska), thus improving their accessibility and the mobility of their population.
