As stated by the EIB, the project mainly concerns the renovation, extension and new construction of public lower-secondary education facilities, as well as other infrastructure receiving pupils and children, in the department of Haute-Garonne. It also includes transversal operations, in particular digitalisation, as well as works related to inclusive access, renewable energy, energy efficiency and energy transition.

The iaim is to modernise and adapt school infrastructure to changes in local demand, while improving the education offering for lower-secondary school students.

Additionally, the project seeks to contribute to provide inclusive access to digitalisation and strengthen resilience to the risks of climate change and increase the energy efficiency of the school estate.

ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
