## Project Description

According to the Bank's website, the project consists of a Forestry Nature-based Solutions fund with a mixed investment strategy focused on (i) restoration of degraded landscapes and ecosystems, (ii) establishment of greenfield plantations, (iii) sustainable forestry operations and (iv) forest infrastructure and value-chain upgrades, in various countries of Latin America.

The Fund will invest in afforestation, reforestation, forest management and conservation projects in Latin America with the objective to promote the profitable expansion of climate and nature-positive forest resources in the region. Latin America is a critical investment target for restoration and conservation of nature with an ability to support the development of nature-based carbon credits that have environmental integrity.

### ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
