#### **Project Description**

As stated by the EIB, the project concerns Acqua Novara VCO's 2025-2030 water and wastewater investment programme, aimed at improving system resilience through interconnections of the water distribution networks, new water sources, and leakage reduction as well as optimisation of existing sewerage treatment facilities.

The aim is to continue support the promoter's investments (e.g. water and wastewater treatment plants, networks and pumping stations) in the Piedmont region.

The EIB finance is backed by SACE's Archimede guarantee - which covers two-thirds of the funding - and the European Union's InvestEU programme - which covers the remaining €50 million.

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
