### **Project Description**

As stated by the EIB, this operation consists of a co-investment alongside the Copenhagen Infrastructure Growth Markets Fund II for the construction and operation of new 396 MW onshore wind farm in Romania.

The Project Pestera II is expected to be built in a dedicated renewable energy area, according to local urban and spatial plans for which a Strategic Environmental Assessment has been carried out.

The wind farm will contribute to achieve the 2030 decarbonisation targets set out in the National Energy and Climate Plan (NECP).

Being located in a Cohesion priority region, the project is eligible under Article 309 (a) "projects for developing less-developed regions" and (c) "common interest".

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
