#### **Project Description**

According to the Bank's website, the Lending Envelope (LE), consisting of sub-operations as multiple beneficiary intermediated loans (MBIL) or Framework Loans (FLs) with acceptable financial intermediaries, will support the reconstruction after the severe floods in Austria, Poland, the Czech Republic, Slovakia, Romania and other Member States.

By providing additional liquidity to banks and other financial institutions, the aim is to support sustainable rebuilding efforts and preventive measures to enhance resilience against future flooding events. As a result, the LE will mitigate the economic impact of the floods and ensure a quicker recovery for the affected communities, by reducing their vulnerability in case of similar disasters in the future.

Final beneficiaries will be small and medium size enterprises (SME), Mid-Caps and/or Public Sector Entities (PSE) in the affected EU Member States.



### **Early Warning System Project Analysis**

The underlying sub-operations under this lending envelope will be subject to separate appraisal process. Overall, these sub-operations are expected to bring about important environmental, climate and social benefits to concerned cities and regions in terms of enhancing flood resilience and climate adaptation against future floods.


When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
