Project Description

As stated by the EIB, the project intends to address legacy infrastructure issues of the Chisinau district heating network. The rehabilitation works will improve efficiency and energy performance, allow the reinstatement of domestic hot water supply in apartments and therefore contribute to decarbonisation.

The investments will contribute to the objective of security of energy supply and climate change mitigation. The project aims at reducing heat and water losses in the district heating network and therefore reducing the related negative "externalities", including reduction of emissions of greenhouse gas and other air pollutants.

The proposed operation mainly focuses on the reconstruction of building-level distribution systems, including the installation of individual heating substations and horizontal pipelines in buildings served by the Chisinau district heating system. The project is expected to reduce heat costs for customers, provide access to hot water for homes connected to the network, and lower greenhouse gas and harmful emissions.

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
