### **Project Description**

According to the Bank's website, the operation will support selected education projects included in the City of Tampere's investment plan.

The aim is to support both major renovations and the new construction of educational buildings. The sub-projects are located in different parts of the city and accommodate different levels of education, ranging from pre-primary to lower secondary education.

### **Early Warning System Project Analysis**

According to the Environmental and Social Data Sheet, all Project components are located in an urban area and are partially covered by an approved land use plan, which can only be set up following a public consultation and the approval of the competent authority. For the rest of the locations, urban planning will be carried out and land use plans will be confirmed before the start of works. Due to the nature of the land use planning process, the Project most likely will not generate significant negative environmental effects during construction and operation.

As the Project concerns construction and refurbishment works in an urban area within or close to the existing facilities, significant environmental impacts are deemed unlikely.

Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
