### **Project Description**

According to the EIB, the project will support ZSE Group's investments in the electricity distribution network.

Specifically, these concern:

- the construction and refurbishment of High Voltage (HV), Medium Voltage (MV) and Low Voltage (LV) overhead lines and underground cables;
- the construction, extension and refurbishment of secondary substations;
- the installation of new transformers and refurbishment of existing ones;
- the automation and tele-control systems.

The aim is to support the upgrade, digitalisation and extension of the promoter's HV electricity distribution networks in both West and East part of Slovakia, over the period 2025-2026.

### **Private Actors Description**

As stated on the company's website, on 1 July 2007, due to the liberalisation of the energy market, ZSE Energia, a.s. became a 100 per cent subsidiary of Západoslovenská energetika, a.s. The spin-off was due to applicable Slovak and EU laws under Act No. 251/2012 Z.z. on Energy. Západoslovenská energetika, a.s. is part of the German energy Group E.ON, who is a 49 per cent shareholder of the company. The Slovak Republic is a 51 per cent shareholder via the Ministry of Economy of the Slovak Republic. In 2011, ZSE Energia, a.s. was also granted a licence for gas supplies.

#### **ACCOUNTABILITY MECHANISM OF EIB**

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
