#### **Project Description**

According to the Bank's website, the Project is a framework loan to support post-earthquake rehabilitation and seismic resilience improvement of buildings and infrastructure in Naples area. The earthquake events occurred since May 2024 caused severe damages to buildings and infrastructure in the Phlegraean Fields area, a volcanic area falling under the municipalities of Naples, Pozzuoli and Bacoli.

Investments include the rehabilitation of private residential buildings damaged by the seismic events since May 2024. The damage repair is coupled with investments aiming at strengthening the seismic resilience of private residential buildings, public buildings (primarily schools) and infrastructure (roads and other key civil infrastructure).

# **Early Warning System Project Analysis**

According to the Environmental and Social Data Sheet, with reference to individual reconstruction schemes, most of them are not expected to cause any significative negative impact on the environment and/or protected natural sites and, therefore, are not subject to an Environmental Impact Assessment.
