#### **Project Description**

As stated by the EIB, the project will finance the following investments for Genova's urban and suburban public transport services:

- (i) acquisition of 152 electric buses
- (ii) Installation of the associated charging infrastructure in five existing depots/terminals
- (iii) construction of 3 new depots for electric vehicles

The aim is to support the renewal and energy transition of the bus fleet towards full electrification, while enhancing the attractiveness of the public transport offering. This is expected to reduce operating costs and improve environmental performance, particularly by lowering air and noise pollution and reducing greenhouse gas emissions.

A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
