The aim is to contribute towards both national and EU energy and decarbonisation objectives.

The project aligns with the EIB's lending policy on social cohesion, renewable energy and climate action. Its revenues will rely on a contract for differences (CfD) and sales on the wholesale market. Consequently, the project contributes to support the market integration of renewable energy projects.

Situated in a Cohesion Priority Region, the project will contribute to support less-developed regions.

ACCOUNTABILITY MECHANISM OF EIB

When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you.
