## Project Description

As stated by the EIB, the proposed operation consists of an equity participation in Mediterrania Capital EU Africa Catalyst, an initiative seeking to support European corporates expanding into Africa.

The operation is expected to enhance trade between the EU and Africa, and contribute to regional integration by supporting European companies in their expansion towards Africa through exports, expanding local presence, or nearshoring strategies.

As such, the fund will establish win-win opportunities by driving private sector growth and foreign direct investment across Africa, while strengthening EU trade, technological presence and value chains on the continent. The fund is being established by Mediterrania Capital Partners - an investment firm that is Spanish at its roots, based in Malta and whose team the EIB has supported as a cornerstone investor since 2005.

## Financial Intermediary

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.

## ACCOUNTABILITY MECHANISM OF EIB

The EIB Complaints Mechanism is designed to facilitate and handle complaints against the EIB by individuals, organizations or corporations affected by EIB activities. When exercising the right to lodge a complaint against the EIB, any member of the public has access to a two-tier procedure, one internal - the Complaints Mechanism Office - and one external - the European Ombudsman. When dissatisfied with a complaint to the EIB Complaints Mechanism, citizens can then turn towards the European Ombudsman. A memorandum of Understanding has been signed between the EIB and the European Ombudsman establishes that citizens (even outside of the EU if the Ombudsman finds their complaint justified) can turn towards the Ombudsman on issues related to 'maladministration' by the EIB. Note that before going to the Ombudsman, an attempt must be made to resolve the case by contacting the EIB. In addition, the complaint must be made within two years of the date when the facts on which your complaint is based became known to you. You can write to the Ombudsman in any of the languages of the European Union.
