According to the bank's website, "The project is a 50-megawatt (MW) solar photovoltaic (PV) power plant in Nilphamari district, which is being developed by Scatec Solar through a SPV named Bangla Sun Solar Limited (BSSL). The project is located in village Baish Pukur, Upazila (Sub-district) Dimla; District Nilphamari; Rangpur Division of North Bangladesh using more than 100 hectares of privately purchased land. The development activity of the project has been started from 2019 and is expecting to generate electricity from 2021.

By implementing the proposed Covid-19 CD project, the underlying PV Project and its employees in Headquarter, local or project site level will acquire more knowledge on the management and mitigation measures of COVID-19, key strategies of business operation and restarting in and post emergency through organizing training and peer learning sessions.
