Project Description

According to the FMO Stakeholder Engagement Team, the project is inactive, and it might have been transferred to [Invest International](#).

The following description has been scraped by the EWS before the project was removed from the FMO's website.

The funding objective is to perform a full feasibility study for the use of Bluecap Hydro turbines in irrigation channels in the Philippines. This includes feasibility studies for 10-15 roll-out locations as well as the installation and testing for 12 months of one turbine in the demonstration location. The ultimate goal is to scale this up to 10-15 locations initially and then a gradual scale-up to 300 sites (subject to public tender), where electricity is provided to local farmers communities and to the national grid.

We fund the project to help Dutch exporters and investors to create positive impact in the Philippines. Project GENIHAR aims to increase the income generation capacity of smallholder farmers in the Philippines, using affordable green energy. The electricity is foreseen to be sold to Irrigation Associations (irrigation cooperatives for local farmers, who are responsible for the operation and maintenance of the irrigation infrastructure), for the use in the irrigation network as well as in post-harvest processing facilities that allow farmers to get higher prices for their produce and to reduce harvest losses. The project replaces obsolete steel stop-locks in existing irrigation infrastructure with fibercore stop-locks with an integrated hydro-turbine. Both the fibercore stoplocks as the turbines will be produced in the Netherlands. There is very limited environmental impact, as no heavy construction is required, and a positive impact of an additional source of renewable energy, available directly to farmer communities.
