### **Project Description**

EVIII will focus predominantly on private finance for the mitigation of climate change and energy transition. The Fund plans to make 10-15 investments of control or significant influence in pan-African assets with core infrastructure and/or growth characteristics, including but not limited to (i) renewable energy generation (utility-scale grid-connected, commercial & industrial (C&I) solar and mini/micro grids), (ii) energy access (distributed generation, off-grid solutions), and (iii) energy and resource efficiency low-carbon growth capital investments across key climate-impact sectors in Africa located largely within sectors that make up the food-energy-water nexus (e.g. energy efficiency for smart cities, digital infra, e-mobility/e-logistics).
