### Project Description

According to the GCF, the project aims to establish and operationalise a national water reuse programme that helps address the water scarcity issue by transforming the country's wastewater system. By treating water as a new asset class and stimulating and activating the water reuse market, South Africa can unlock future economic growth while protecting its scarce and increasingly demanded water-resources. The funding from GCF will reduce the risk exposure of potential private financiers and municipalities by blending GCF funds with funds from private investors while providing key stakeholders with technical assistance and capacity-building.
