The project's specific objective is to improve the quality of public transportation through the renovation and electrification of the passenger rail service of the General San Martín Railroad (FCSM) in the section between the Retiro and Pilar stations, which will reduce travel times, improve the reliability of service, and decrease greenhouse gas emissions.
