## Project Description

The objective of this second and final operation in a series of two consecutive operations to support policy reforms under the programmatic policy-based loan modality, is to help increase coverage and improve the management of potable water and sanitation services and the management of water resources in Bolivia, through the development of an institutional and policy framework that includes actions intended to: (i) strengthen sector planning; (ii) strengthen the organisational and institutional development of sector entities; (iii) support effective implementation of the financial policy; and (iv) develop monitoring and evaluation instruments.
