The aim of this TC is to support the preparation of the Policy Reform Program of the Water, Sanitation, Solid Waste and Water Resources Sectors (BO-L1200) Phase I and Phase II, to contribute to sector's sustainability through a process of reforms to improve governance and management of drinking water services, basic sanitation that includes solid waste management, and water resources in a context of Climate Change, leading to water security.
