### Project Description

The objective of Technical Cooperation BO-T1367 is to strengthen the capacity of the Ministry for Environment and Water (MMAyA) for the organization of the VI LATINOSAN Conference. The CT will support the MMAyA in the preparation of the contents of the VI LATINOSAN Conference, as well as in the technical and logistics aspects.

Bolivia será la sede de la VI Conferencia de LATINOSAN, que se realizará en marzo de 2022 en la ciudad de Santa Cruz de la Sierra. La organización está liderada por el Ministerio de Medio Ambiente y Agua (MMAyA), instancia que coordinará con otras instituciones nacionales e internacionales para los aspectos técnicos, logísticos, financieros y de comunicaciones. La preparación de un evento de esta naturaleza -Conferencia regional que tiene lugar cada 3 años-, requiere de una etapa de preparación que inicia prácticamente desde la finalización del evento anterior, el que tuvo lugar en San José (Costa Rica) en abril 2019.
