The specific objectives are: (i) to develop the legal and procedural regulations for the creation of a fund for the consolidation of TIOC; (ii) to establish the Fund's management and administration team; and iii) to strengthen the technical capacities of the Instituto Nacional de Reforma Agraria (INRA; National Institute for Agrarian Reform) and prioritized TIOC to reduce deforestation and increase sustainable forest management.
