Project Description

The general objective of this Investment Grant (IGR) is to promote forest conservation by strengthening the livelihoods of indigenous peoples, quilombolas and traditional communities (PIQCTs) in collective territories in Terra do Meio, in the state of Para. Its specific objectives are: (i) Promote the formal recognition of IPQCT as providers of environmental services for the conservation and sustainable management of Collective Territories in Terra do Meio; (ii) Strengthen the inclusive governance of forest conservation policies for IPQCT in Collective Territories.
