### Project Description

The program's overall objective is to promote the sustainable urban mobility of the Município of Santo André (MSA), through: (i) the construction and rehabilitation of road infrastructure to enhance the integration of the MSA and the Metropolitan Region of São Paulo, both internally and with the country's other regions, and with the port of Santos; and (ii) the implementation of a more efficient transportation system, giving priority to the operation of public and non-motorized modes of transportation.

These objectives are also expected to contribute to the reduction of traffic accidents and polluting gas emissions
