The objective of the project is to contribute to improve the quality of life of the resident population in the basins of the Igarapés Ilha de Coco, Guanabara and Chácara das Estrelas, through the implementation of sustainable infrastructure works of urban planning, macro and micro drainage, water supply and sanitary sewerage.
