The specific objectives of the TC are: (i) to provide comprehensive technical assistance for the planning, design and implementation of projects, including specialized studies, prefeasibility, technical, economic and environmental assessment, and social management plans, among others; and (ii) to support institutional strengthening and provide technical assistance to improve the sustainability and resilience of transport infrastructure and services, as well as to promote innovation, gender equality and inclusion in the sector.
