Specifically, this TC will (i) provide technical assistance to municipalities for the design, preparation, and execution of integrated urban development programs, with a focus on sustainability and climate resilience; and (ii) strengthen institutional capacities to ensure projects incorporate technical, environmental, and social analyses, consistent with international and sectoral best practices.
