The specific objectives are: (i) to finance economic, social inclusion, productivity, and legal studies to assess the overall feasibility, sustainability, and enabling framework of the program; (ii) to finance technical and environmental studies that support the technical design of the program and ensure its alignment with the principles of climate sustainability and operational efficiency; and (iii) to finance complementary engineering studies and analyses required for the definition and structuring of the program.
