Project Description

This project seeks to improve the integration and provision of services for labor mediation for employment seekers and businesses in Chile. To do so, it seeks funding from the IDB to revise the governance model of labor mediation services (servicios de intermediación laboral, SIL), adjust the SIL's services and restructure its administration, and create an information system for the labor market and increased understanding of the sector.

The project builds on a series of previous projects: CH-L1064, CH-T1120, CH-L1095, CH-T1175, and CH-T1179.
