Project Description

According to the Inter-American Development Bank, the general objective of this project is "to help reduce violent robberies and improve Chile's capacity to manage cyber incidents and cybercrimes. Its specific objectives are to: (i) improve police capacity to prevent and investigate violent robberies in the Santiago metropolitan region; (ii) reduce antisocial and criminal behavior among young people (ages 10 through 17) in prioritized municipalities of the Santiago metropolitan region; and (iii) improve the capacity of the Ministry of the Interior and Public Security to manage cyber incidents."
